The next time you're visiting TCH, take a moment to notice the inscription at the base of our flagpole. It speaks of "a spirit that brought neighbors together in friendship and help," a timeless message that continues to guide us today, reminding us that community is built not only through service, but through shared moments of joy.

Founded by families seeking a place for neighbors to connect and support one another, The Community House has always been about creating space for connection, shared experience, and belonging. In 2025, that spirit was evident in meaningful and inspiring ways. At Bloom to Grow, community members came together with exceptional generosity, resulting in the largest paddle raise in the history of the event. This same commitment to access and connection guided several meaningful additions to our programming in 2025. We introduced Family Fun Nights, creating opportunities for neighbors and families to simply come together and have fun. We also expanded opportunities for our youngest community members through offerings such as toddler art classes and Little Lights, Stage 284's theater education program for beginners. And we've partnered with The Council on Aging to create a "Lunch and Linger" gathering with the purpose to create a welcoming space for food and fellowship. Across all our programs, financial assistance remains a commitment, ensuring that children and families can participate in The Kids Community childcare program, Stage 284 classes and camps, and other offerings that strengthen connection.

As we look ahead to 2026, we do so with confidence and care. This work continues thanks to families whose time, generosity, and spirit of collaboration remain essential to who we are. We remain focused on sustaining strong programs, maintaining welcoming spaces, and serving as a place for connection and support. With your continued stewardship, the year ahead holds great promise!







2025 Patton Award

In May 2025, The Community House honored Heather Ford with the Joanne Holbrook Patton Community Service Award, recognizing her lifelong dedication to service, leadership, and making Hamilton-Wenham stronger.

Heather's commitment to public service spans decades. From her early work on the Hamilton Conservation Commission to leadership roles on the Waste Reduction Committee and the Board of Selectmen, she has been a steadfast advocate for sustainability and civic engagement. She played a key role in establishing the town's recycling and composting programs that continue to benefit residents today.

Beyond her work in government, Heather has been a devoted mentor to young people. As a Girl Scout Troop Leader for more than ten years, she guided seven of her troop members to earn the prestigious Girl Scout Gold Award, an honor achieved by only about 5% of eligible scouts nationwide. She continues to support the organization through board and committee service focused on scholarships and long-term planning.

Recognizing a growing need in the community, Heather co-founded the Hamilton Foundation in 2005, evolving the town's Holiday Assistance Fund into a year-round resource supporting residents facing financial hardship. Under her guidance, the foundation now raises and distributes up to \$20,000 annually to help families with rent, utilities, and food security.

A community member reflected on Heather's impact: "Heather gives her time and energy without hesitation, ensuring that those in need are supported and that our community remains a wonderful place to live." It was the honor and pleasure of The Community House to recognize such a quiet, selfless powerhouse of community. Heather Ford's dedication, leadership, and generosity serve as an inspiring example, showing how one person's commitment can create lasting, meaningful change.





The Kids Community

The Kids Community (TKC) is an EEC state-licensed program, providing safe, engaging, and affordable childcare for students in kindergarten through 5th grade. Through hands-on experiences in the arts, science, technology, and recreation, children learn, explore, and build meaningful connections. Throughout the year, TKC emphasizes relationship-building, community, and social-emotional growth.

In 2025, 309 children participated across our before- and after-school programs and summer camps. Students benefited from 20 visiting enrichment programs, including Lego Robotics, Parties by Carole, Audubon, and other hands-on learning experiences. This year also brought an increase in our licensing capacity, allowing us to serve even more families. Looking ahead, we are introducing exciting new grade-level-based themes for Summer 2026, designed specifically for students in K–2 and 3–5 to ensure age-appropriate engagement and growth.



Stage 284

This year marked an important moment of growth for Stage 284. We welcomed two outstanding leaders to our team: Cassie Foote as Managing Director and Noël Cody-Mumford as Education Director. Together, our expanded leadership strengthened the artistic and educational foundation of the program.

Productions of *School of Rock*, *Descendants*, *The Rocky Horror Show*, and *The Addams Family* engaged more than **6,700 audience members**.

Summer camps reached capacity within days of opening registration, reflecting both strong demand and the trust families place in our programs. The Young Adult Intensive production of *Head Over Heels*, featuring two casts and performers from across New England, was a standout success and further established Stage 284 as a destination for serious young artists.

Two new initiatives were launched: **Rising Stars**, designed to deepen training and mentorship for emerging performers, and **Little Lights**, welcoming our youngest artists with age-appropriate programming that fosters confidence and creativity.

Ski Bradford

In January 2025, the Ski Bradford program enjoyed another successful season out on the slopes. The program was opened for grades 3-5, with 144 participants. (A 32% increase over the past year!) Scholarships were awarded to help families access this program for their children, giving all kids in our community a chance to get outside to enjoy fun with friends.



Friends Club

The Community House has been serving the interests of local adults with diverse abilities for over 40 years through regular social events. Thanks to the generosity of donors, TCH offers this program of friendship and fellowship free of charge.



Creative Corner

Introduced in 2025, Creative Corner is a new program created in response to family feedback seeking enriching experiences for their youngest children. Designed for ages 18 months to 5 years, the program offers engaging 60-minute classes that encourage creativity and exploration.

The program features Art & Sensory Play and Movement through Music & Storytelling, two 6-week offerings that support early development through open-ended, play-based learning while nurturing imagination and self-expression.



Middle School Program

The Community House's Middle School Night program allows middle school aged youth to enjoy safe and supervised social activities. Our Middle School Dances served 280 students in 2025. A 5th grade party at the end of the school year has been a popular addition to the program.



The Music Man

Brian Doser, known as the Music Man, is a multi-talented musician and signer who produces live musical performances for toddlers and their caregivers. Performances are held at TCH on Wednesdays and at Creative Co-Op in Topsfield on Thursdays at 10:00am. This program is a wonderful, low-pressure introduction to music, movement, and socialization.



Community Events

Community Block Party

The 2025 Block Party was a perfect day filled with laughter, excitement, and community spirit. Thanks to the generosity of donors, this year's event was completely FREE for all, offering an easy and accessible way for families and neighbors to drop in and enjoy.
